COMPLAINT: DURING LOT CHECK TECH FOUND THE ROOF IS LEAKING AND CAUSED WATER DAMAGE WITHIN THE UNIT

CAUSE: TECH VERIFIED WATER IS GETTING INTO UNIT FROM THE FRONT DS GUTTER RAIL NOT BEING SEALED CORRECTLY AT FACTORY. ALSO FOUND SMALL OPEN VOID IN SEALANT ON ROOF. THESE ISSUES HAVE ALLOWED WATER TO ENTER UNIT AND DAMAGE A CEILING PANEL, LOWER FRONT INT PANEL, GRAY PANEL AT SIDE OF MATTRESS AND WATER ON PLASTIC COVERING OF MATTRESS.

CORRECTION: SEAL GUTTER RAILING AND VOID ON FRONT TO PREVENT FURTHER LEAKING/DAMAGE. REMOVE AND REPLACE THE CEILING PANEL THAT IS CURVED, WALL PANEL WHERE ELECTRICAL OUTLET IS, LOWER GRAY PANEL AT MATTRESS AND CLEAN MATTRESS PLASTIC COVERING.
