Complaint: The valve stem on the front axle on the door side of the camper has stuck open twice when checking the tire pressure, resulting in a flat tire. Need to inspect the valve stem.

Cause: The valve core is getting stuck when putting air in or checking the tire pressure.

Correction: Will need a new valve stem.

Please find the attached form and request for 0.5 hour to remove and reinstall the tire and a sublet for \$8.79 to replace the stem valve.
