COMPLAINT: CUSTOMER STATES REPAIR CARPET ON SLIDE (REFERENCE: 71948)

CAUSE: Rip in carpet

CORRECTION: Started this job by removing the cushions from the dinette, removing the access covers for the under the bench storing. Remove the table by lifting it off of the legs remove both legs. Remove the panel from the back of the bench for the dinette on both sides. Unscrewed each of the benches, removing several doesnts screws, lifting the bench and setting it aside from each side of the dinette table. Leg post supports from the floor for the dinette table, removing over a dozen screws. Went to the couch, lifted the base of the couch upwards removed two screws from each side, picking up the couch and setting it aside removed nearly a dozen screws to remove the couch base, lifting it out of the way and setting aside removed the facia from all the way around the entire slide, both sides and the top. Remove the slide stops from each side of the slide room. The escape full access to the entire piece of carpet. Remove the paneling from both ends of the slide room, removing the window, retaining ring, removing the blind and the cover or Trim, removed and pulled all staples and nails from both walls from all the facia from all the trim that was removed. Went along the edge of the floor plate cutting the carpet cut the carpet along the paneling on the backside or the long side. Rolled up and remove the damaged carpet. Got the new carpet out of the tube, laid it out in the shop on top of a large piece of cardboard laid the new piece out completely, so it would lay flat laid the old piece on top of the new piece, got it perfectly, squared and set on the new piece marked it all the way around and cut the new piece to fit took the new piece inside, laid it on the floor beginning on the rear of the slide, tucked the new carpet underneath the edge of the floor plate work my way down the long side of the wall, tucking it in underneath the paneling all the way to the front side the carpet was trimmed as needed as I moved from one end to the other, ensuring that the carpet light flat once the carpet was completely tucked under the floor plates in the paneling, using a crown, staple gun stapled the carpet down along the floor plates and along the paneling all the way around the entire room. We began putting all trim back on where it came off from the side of the couch and behind the couch, I put the bat along the floor. Reinstalled the paneling on both ends of the slide room, reinstall the retaining ring for the window, the window blind, and the top trim piece, but the set screws in place for the tension of the blind adjusted the blind appropriately. Reinstalled all batten trim around the paneling that was removed. Reinstalled the slide stops on both ends of the slide room cut a new top facia for the slide room and installed put the side facia back on each end of the slide room, along with the corner, trim pieces, reinstall the base for the couch and reinstall the couch. Reinstalled both benches for the dinette staple the back paneling back in place reinstalled the base for the table, post puttied all nail holes and staples in the paneling and trim throughout

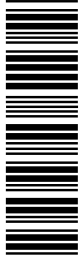

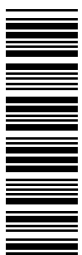
