COMPLAINT: THE REFRIGERATOR WILL NOT COME ON AT ALL.

CAUSE: Customer states that the refrigerator is not powering on. Pulled unit in the shop and plugged into Shore power. Refrigerator will not respond. Got a cart and set in front of refrigerator. Pulled refrigerator on to cart. Tested voltage on fridge. Fridge has 13.6 going to it. Removed grate cover on the back of the fridge. Noticed the positive Spade connector was loose.

CORRECTION: Remove Spade connector and tightened down with needle nose pliers to help hold. Plugged in fridge and tested overnight. Fridge is cooling as it should. Fridge temperature tested at 38° set at normal. Installed rear cover. Set fridge back into cut out. Secured fridge with provided screws. Removed cart from unit. Cleaned up mess. Parked unit
