So approximately it took me almost 2 hours. Order number 71359. That is dedicated to the recall. I had to cut the underbelly peel away. All the unhooked the wires from the 12 V 30AM breaker underneath the unit. While doing so, both of them ended up, breaki had to get 2 new 30 amps. Install them. I had to make a jumper wire from the hot side of one to the other. As though the jumper plate would not fit. Because the 2 30 amps do not set right next to each other. I made a new loop end on the breakaway switch wire. I installed it on the battery disconnect. On the battery hot side. I put the plate back on the Junction box underneath the camper. Repaired the underneath of the camper was underbelly Tape Checked for proper breakaway operation when battery disconnect is in the off position. And everything worked as it should.
