Water damage end panel

CORRECTION: Removed door. Removed loose paper and sanded down. Put new paper on and trimmed. Put door back. Side of couch wood came in damaged. Ordered new one. 12/27/23
Unscrewed the foldable couch then then screws holding in the end panel. Used a rubber mallet to remove the end panel from the structural wood. Pulled the staples from the damaged end panel and structural wood. Aligned the end panel to the structural wood then stapled in place. Put water damage end panel in warranty department. Set and screwed the end panel in place. Set foldable couch in place then screwed down to the end panel.
