Found that the bolt that holds the release lever in the lower
part of the chair i've come loose.
I removed the center section of the recliners. I tried. To see
if I could find anything broken underneath. I did not see
anything so I removed the defective recliner. When I flipped over
the recliner, I found that the bolt that holds the release lever
had worked itself out of the nut holding it in place. I tightened
the bolt and tested the chair. The recliner is now working as it
should. I reassembled the couch and tested both recliners.
