After inspection the tv power booster not working so I replaced
it and it works properly now

77664 2 JACK NOT WORKING
Bad ground contact
Turned the jack light on and it lit then pushed the button for
the jack to go up or down and the jack light went out. Checked
the wire at the circuit breaker by removing it and connecting it
directly to the battery and still got nothing from the jack
motor. Checked the ground where the jack bolts to the coupler.
There were washers on top of the star washers. Unbolted one of
the bolts and removed the washer but left the star washer in
place. Tightened the bolt then pushed the button for the jack
motor and it works. With the washer in place, there was not
enough ground contact.
