CAUSE: Replace insert trim

CORRECTION: Went to unit and removed screws at bottom of trim then grsbbd ladder and went to top and removed screw holding trim in place. Placed new trim on sides from top to bottom. Secured trim in place with screws at top and bottom. Door side trim on top was bad as well. Cut silcione and removed screws holding old trim in. Secured trim with a screw at one end and place trim in track along rail on door side. Placed screw in at other end to secure. Used black silcione to cover screws at front and back of trim rail.
