COMPLAINT: WARRANTY ITEM

CAUSE: Water pump kills battery power when running. Water pump only works when living room light switch is on. All lights dim severely when pump is running and power drops from 13.5 to 10.3 volts. Converter, battery and 120 in are all passing inspection.

CORRECTION: After extensive diagnostics, found no dedicated circuit for monitor panel or water pump. Ground supply was bad to bathroom wiring as well. Ran test circuits to verify problem and confirm resolution. Need to run a dedicated circuit from panel in living room to water pump controls in bathroom. Must run new ground from 12 volt distribution panel to bathroom to resolve bad ground issue. Must remove water pump from living room light circuit. Need 8.0 hrs
