Found one decal at drivers rear lower black stripe bubble 3 1/2x48, 2 decals at drivers side front top, the black stripe is bubbling tapered 4 1/2 at the front 1 1/2 at the rear and 12 feet long. Three decals on the passenger side, same decal at drivers side #2. Correction: Attempted to smooth the bubbles out, the decals are already stretched out and will not lay back down without creases or wrinkles. Recommend replacement of decals. This will require removing each decal and cleaning the surface. The decal on the drivers side rear will require removing the shore cord plug and placing the decal on and then reinstalling the shore cord plug. Decal 2 on driver side front will require fitting it around the window. Decal 3 at passenger side front will require fitting it around the window and under the awning mounting bracket. Requesting 3.0 hours for all decals.
