CORRECTION: Winterized the unit. Found antifreeze coming out of the bottom board passenger side behind the axel.
 Traced the leak to the shower drain. Had to remove 4 screws and take the access cover off
 Found antifreeze below the swivel nut.
 Unscrewed the Ptrap checked the gasket found it had debris under it. Cleaned the fitting and the gasket
 reinstalled the Ptrap. Poured antifreeze in the shower drain is no longer leaking.
 Reinstalled the access panel with the 4 screws work completed
