CAUSE: Toilet will not hold water in the bowl

CORRECTION: Poured water in the toilet bowl , very rapidly the water leaked out of the bowl
Checked and cleaned the seal in the bowl and retested again the water leaked out very quickly

Recommend replacement of the toilet

Removed old seal

Completely cleaned the the seal area with cleaner cleaned the top on the flush bulb with cleaner

Installed the new seal insured it was seated properly all the way around

Pressed the flush lever several times to make sure everything moved correctly

Added water to the bowl and it drained out just as fast as the old seal.

Brought Brian and Chris out added water again and it drained very quickly

Renew recommendation to replace the the toilet completely

Request an additional hour for removal and new install

Removed old toilet in hooking the water line and two side bolts

Installed new toilet hooked up the water line and tightened the two side bolts
