COMPLAINT: CUSTOMER STATES FURNACE WILL TURN ON BLOWS, BUT NO WARM AIR

CAUSE: Furnace would run with a flame and shut off then turn back on not run long enough to warm the unit

CORRECTION: Plugged the unit into shore power

Checked to make sure the gas was on

Turned the furnace on watch through the peep hole and could see a flame

After several minutes the flame began turning on and off . Would run come for 15 to 30 seconds and turn off

Tested the operating pressure and found it to be 10.5 adjusted it to 11

Disconnected the furnace including the gas line thermostat wires and power wires

Removed the screws and pulled the exhaust out.

Took the furnace in the shop

Tested circuit board and found it was working correctly

Bench tested the furnace and found it was operating correctly

Reinstalled the furnace connected the gas thermostat and power

Turned the furnace on and was operating the same way.

Disconnected the thermostat and power

Used a outside power source and the furnace operated correctly with house propane

Connected the house power and tested the furnace again and was operating correctly

Connected the thermostat and the furnace began turning on and off as it was doing before

Connected an analog thermostat and the furnace was working properly

Found the thermostat was not working properly and recommend replacement

The analog thermostat was left connected the customer lives in the unit
