CAUSE: Theres a brace on the inside of the wall for the pocket door. The staples did not hold and the wood popped out enough to contact the door when its fully closed.

CORRECTION: remove the upper header board, unclipped the door and remove the door from the track. Unsecured piece of wood.. We can hold the piece of wood up against the wood panel and staple the wood panel behind the toilet to resecure the board inside the wall. Fill all holes with putty and stain to match rehang the door and reinstall the header board. Job completed.
